LICENSE AGREEMENT – This License Agreement and Maintenance Agreement is between you (“Licensee”) and Geotech Computer Systems, Inc. (“Geotech”), a Colorado corporation, with a place of business at 12220 E. Briarwood Ave. Suite 152, Centennial, CO 80112 USA.

The software packages are protected by United States Copyright Law and International Treaty provisions. The Software and Documentation are licensed and not sold. Geotech owns the Software and Documentation. From the date of receipt, Licensee agrees to use reasonable means to protect the Software and Documentation from unauthorized use, reproduction, distribution, or publication. Geotech reserves the right to improve and/or make changes in its offerings of the software or documentation at any time.

DEFINITIONS – The Terms used are defined as follows:

1. “Documentation” means all of the printed and digital materials including, but not limited to, help files, user reference documentation, training documentation, or technical information and briefings.
2. “Software” means the actual copy of all or any portion of Geotech’s proprietary software technology, computer software code, components, dynamic link libraries (DLLs), underlying organization, object model, and programs delivered on any media, including any release provided in source, object, or executable code formats(s), inclusive of backups, updates, service packs, patches, hot fixes, sample code, sample application, sample extension, or merged copies permitted hereunder.
3. “Single Use License” means Licensee may permit a single authorized end user to install and use the Software and Documentation on a single computer for use by that end user on the computer on which the Software is installed. Licensee may permit the single authorized end user to make a second copy for end user’s exclusive use on a portable computer so long as only one (1) copy of the Software and Documentation is in use at any one time.
4. “Concurrent Use License” means Licensee may install and use the Software and Documentation on computer(s) on a network, but the number of simultaneous users may not exceed the number of licenses purchased.

USES PERMITTED - Each license is for use on one machine at a time by a single user at a time unless specifically licensed for concurrent use. The package may be used by any number of people and moved from one computer to another so long as there is no possibility of it being used at one location while it is being used at another. You are authorized to make archival copies of the software for the sole purpose of protecting your investment from loss. You may also copy the software onto a hard disk as required for use.

If you have purchased a software license, you should have received a temporary unlock code with it. You can use this temporary code for thirty days. We will send this permanent unlock code to you once we have received from you a signed License and Maintenance Agreement and payment for the software.

If you are renting the software, you should have received a Rental unlock code with it. You can use this Rental code for thirty days. If you decide to renew your Rental Agreement, a new Rental unlock code will be sent to you for each 30-day renewal.

You may transfer this package to another party if you first notify Geotech of the proposed transfer, that party agrees to the terms of this agreement, if all copies of the programs and documentation are transferred or destroyed, and if the new party signs and returns a new License Agreement. If Geotech is not notified of this transfer in writing, this License and Maintenance Agreement becomes null and void. By using this program you agree to abide by the License and Maintenance Agreement as set forth in this document.

USES NOT PERMITTED – Except as provided herein:

1. Licensee shall not sell, rent, lease, sublicense, lend, assign, or time-share the Software or Documentation.
2. Licensee shall not redistribute the Software to third parties, in whole or in part.
3. Licensee shall not reverse engineer, decompile, or disassemble the Software or Documentation.
4. Except to the extent that applicable law prohibits this restriction, Licensee shall not make any attempt to circumvent the technological measures that controls access to, or use of, the Software and Documentation.
5. Licensee shall not redistribute the Software unlock codes except as permitted based on the number and type of license(s) purchased.

TERM AND TERMINATION - This license is effective upon acceptance of this License Agreement and shall continue until (i) such time that Licensee elects in writing to discontinue use of the Software or Documentation and terminates the license; (ii) expiration of the license; (iii) either party terminates the license for a material breach that is not cured within ten (10) days of written notice to the other party, except that termination is immediate for a material breach of a nature that it is impossible to cure. Upon termination of a license, Licensee shall (i) uninstall, remove, and destroy all Software and Documentation, and any copies or modifications in any form, and execute and deliver evidence of such actions to Geotech.

LIMITED WARRANTY - Geotech Computer Systems, Inc. warrants the delivery media and documentation included with this package to be free from defects in materials and workmanship for a period of 30 days from the date of purchase. If such defects should turn up within the warranty period, Geotech will replace the defective item. 2. Licensee can create as many of these sets of tables and other objects as necessary for their use, but only on the number of servers shown below. The data model(s) can be implemented on one or more additional server(s) for the sole purpose of redundant backup.
3. Licensee is responsible for providing a properly licensed copy of the server database software (Microsoft® SQL Server® or Oracle®)
4. Licensee must have a separate paid-up client license for each Enviro Data client copy that they will be using.

Maintenance Agreement

Each maintenance agreement will be for a specified period of time for a specific number of licenses of one or more products. This information will be provided on the invoice for the maintenance agreement.

This Maintenance Agreement will be automatically renewed each year unless written notice of termination is received thirty days prior to expiration, by Geotech Computer Systems. Geotech Computer Systems will initiate the invoice when the Maintenance Agreement becomes automatically renewable. The price for a year of maintenance for each product is based on 20% of the list price of the product at the time of the renewal.

Time spent working with the client on software bugs will not be charged against their support time. A “bug” is an error in the specified logic of the software that prevents a function in the software from working, or generates an incorrect result when run with valid data. A flaw in the data that prevents it from being selected, displayed, reported, calculated, imported or exported correctly is not a bug, but a problem with the data. Missing or flawed data, unless caused by the software, is not a bug. An enhancement is a change to the program code to make the program easier to
